## **Affordable Care Act Open Enrollment**



FIU faculty and staff who are currently uninsured can review options through the Health Insurance Marketplace during the Affordable Care Act's open enrollment period. The Open Enrollment Period ends December 15, 2017. Financial assistance may be available to qualifying individuals and families. Those who enrolled last year should re-enroll in the Marketplace for 2017 Coverage. The Affordable Care Act is still fully in effect and you may be penalized if you do not maintain coverage throughout the year. FIU will be hosting several enrollment services during the 2017 open enrollment period at the following dates and times:
